For the purposes of the present AGREEMENT the following terms are used:

**Forum – International Forum “ATOMEXPO 2021”; the Exhibition and Congress are organized as part of ATOMEXPO 2021;**

**Forum location: Main media center, Olimpiyskiy prospect 1, Sochi, Russia.**

**AGREEMENT: This agreement for participation in the Congress of the International Forum ATOMEXPO 2021;**

**Congress: Congress of the International Forum ATOMEXPO 2021;**

**Congress dates: April 26-27, 2021;**

**Organizer: LIMITED LIABILITY COMPANY INFORMATION AND EXHIBITION CENTER OF NUCLEAR INDUSTRY (ATOMEXPO LLC);**

**Participant: the person, on behalf of whom the AGREEMENT is signed;**

**Delegate: representative of the Participant at the Congress;**

**LIST OF SERVICES:**

Participation in all sessions of the Congress, attendance at the ATOMEXPO 2021 exhibition, informational support, Congress materials, the official electronic catalogue of the ATOMEXPO 2021 Forum, branded merchandise, participation in the Gala Dinner celebrating the opening of ATOMEXPO 2021 and a pass to the lunch area (lunches and coffee breaks).

**PAYMENT PROCEDURE:** The Participant receives an invoice on the basis of a completed and signed AGREEMENT. Payment is made by wire transfer in the account currency (Euro). Full payment must be made to the Organizer’s bank account within 15 (fifteen) of the invoice issue date. **All bank charges and commissions are debited to the Payer’s account.**

The day of payment is considered the day that the funds are received by the Organizer’s bank account. Speakers must pay the registration fee no later than **March 22, 2021**. Delegates who do not intend to speak at the event must pay the registration fee no later than **April 12, 2021**. The participation fee is non-refundable in the event that a registered delegate is unable to attend the Congress. The Participant shall have the right to replace the delegate.

After the Congress, the Participant shall sign an Act of Acceptance for the services provided. The Participant must sign the Act of Acceptance within five days of receipt. If the Participant does not sign the Act of Acceptance for the services provided within five days of receipt, the services shall be deemed to have been provided by the Participant.

The **REGISTRATION FEE** shall cover the participation of a single delegate in all sessions of the Congress and round table discussions; lunches and coffee breaks; the Official electronic catalogue of the ATOMEXPO 2021 exhibition; a delegate’s badge (which is also valid for the ATOMEXPO 2021 exhibition); informational support; Congress papers; and an invitation to the gala celebrating the opening of ATOMEXPO 2021.

**NOTE: The Organizer’s obligations arise after the Participant has paid 100% of the participation fees.**

**AGENDA:** The Congress programme will include a plenary session, breakout sessions and round-table discussions. Sessions will be held in the Main Media Center. The Congress languages are Russian and English. Speakers are provided with computers and projection devices.

**INFORMATION FOR SPEAKERS:** A registered delegate may make a presentation or statement at one of the Congress events, if confirmed by the Congress Organizing Committee. The duration and topic of the presentation shall also be confirmed by the Congress Organizing Committee. The presentation topic shall correspond to the topic of the event. Applications for giving a presentation, including abstracts of their content, shall be submitted in Russian and English in electronic form no later than **March 22, 2021** to [atomexpo@atomexpo.com](mailto:atomexpo@atomexpo.com). By the beginning of the Congress, a Collection of Abstracts will be compiled based on the information received from speakers. The application must include official permission to publish the paper in the open press. Congress materials in Russian and English will be published according to the information received from the speakers. Materials must be prepared in Microsoft Word, Times New Roman font size 12 and single-spaced. Materials are submitted in electronic form and can be up to two printed pages including tables, figures and references. Margins: left, top and bottom – 2cm, right – 1.5cm. The title of the presentation, names of the speakers and the organization should be indicated in the upper section of the abstract. Illustrations (including formulas, tables, graphs and diagrams) should be numbered in the order that they appear in the presentation and have captions.

**RESPONSIBILITIES OF THE PARTIES:** Each of the parties is liable for the fulfilment of its duties under the present AGREEMENT, in compliance with the existing legislation of the Russian Federation. The Participant may demand in writing that the Organizer eliminate any shortcomings in the provision of the services within no more than one business day from the receipt of the corresponding written request from the Participant. If the Participant does not issue any demand to eliminate shortcomings, the services shall be deemed to have been properly provided. The rights and responsibilities of the Participant stipulated in this AGREEMENT cannot be transferred to third parties. The Participant shall reimburse the Organizer for damage caused to the Organizer’s property, as well as any expenses incurred by the Organizer to compensate for the damage caused by the Participant to property belonging to a third party. In the event that the Participant violates the payment dates, the Organizer shall have the right to refuse to fulfil this AGREEMENT and prevent the Participant’s Delegate from taking part in the Congress. The Organizer is not liable for the loss of or damage to exhibits or tangible property owned by the Participant incurred during the course of assembly, disassembly and work of the Congress.

**REFUSAL TO PARTICIPATE:** In the event that the Participant refuses to take part in the Congress or fulfil the terms of the present AGREEMENT after it has been signed, the Participant shall pay a penalty of 100% (one hundred per cent) of the Conference participation costs as set out on the first page of the present AGREEMENT, if such refusal was received less than 30 days before the Conference is set to begin.

**FORCE MAJEURE:** The Parties are not liable for the failure to fulfil, or the improper fulfilment, of their obligations under this AGREEMENT if such failure is the result of circumstances beyond their reasonable control, i.e. extraordinary and unavoidable circumstances under the given conditions, including a fire, terrorist act, natural disasters, war, military actions of any nature, and decisions of state bodies. The Party that fails to fulfil, or improperly fulfils, its obligations due to circumstances beyond its reasonable control shall immediately inform another Party upon occurrence thereof. Documents (references) issued by the relevant competent authorities shall serve as proper evidence of the existence of the said circumstances and their duration.

**SETTLEMENT OF DISPUTES:** Any dispute, disagreement, or claim arising from or in connection with this Agreement, including those related to its breach, conclusion, modification, termination, or invalidation, shall be settled by negotiation, and if no agreement is reached, shall be resolved by arbitration administered by the Russian Arbitration Center under the autonomous non-profit organization Russian Institute of Modern Arbitration in accordance with the Rules of the Branch of the Russian Arbitration Center under the autonomous non-profit organization Russian Institute of Modern Arbitration for the resolution of disputes in the nuclear industry, and if it is determined during arbitration that the dispute does not constitute a dispute in the nuclear industry, it shall be resolved in accordance with other applicable rules of the Russian Arbitration Center under the autonomous non-profit organization Russian Institute of Modern Arbitration. The decision of the Russian Arbitration Center under the autonomous non-profit organization Russian Institute of Modern Arbitration shall be final. The applicable law shall be the legislation of the Russian Federation. The Russian language shall be used to resolve the dispute. When interpreting the text of the AGREEMENT, the Russian text shall take precedence.

This AGREEMENT is made in two copies having equal legal effect, one copy for each of the Parties.

**TERM OF VALIDITY:** This AGREEMENT shall enter into force on the day of its signing by both Parties and be valid until August 31, 2021.
